Mu dheidhinn na maoine seo

Tha a’ mhaoin seo ri fhaighinn bho Bhòrd na Gàidhlig gus taic a thoirt do dhaoine a tha ag obair a dh’ionnsaigh dreuchd mar neach-teagaisg Gàidhlig no ann am foghlam tràth-bhliadhnaichean is cùram-chloinne Gàidhlig agus airson cothroman trèanaidh a bharrachd a thoirt do luchd-teagaisg a tha an sàs ann am foghlam tron Ghàidhlig a-cheana.

Tha a’ mhaoin seo fosgailte airson iarrtasan airson cùrsaichean a tha ruith sa bhliadhna acadaimigich 2024/25 (Lùnastal 2024 – Iuchar 2025) a-mhàin.

About this fund

This fund is available from Bòrd na Gàidhlig to provide support to those working towards a career in Gaelic teaching or Gaelic early learning & childcare and to provide further training opportunities to teachers already involved in Gaelic-medium education.

The fund is currently open for applications for courses running in the 2024/25 academic year (August 2024 – July 2025) only.

Cò dh’fhaodas iarrtas a chur a-steach?

Who can apply?

There are three types of students that are eligible to apply via this scheme:

Students enrolled on a Gaelic teaching course

- Students undertaking a Gaelic Education undergraduate Degree (BA/MA Education or MA Gaelic with Education)
- Students undertaking a PGDE in Gaelic Education (either Primary or Secondary – Gaelic as a subject and subjects through the medium of Gaelic)

Students enrolled on a Gaelic early-years or childcare course

- Students undertaking an HNC or HND in Gaelic early years or childcare

Qualified teachers

- Qualified teachers that are employed by a Scottish local authority in a role relating to Gaelic-medium education that wish to undertake a course to develop their skills; or
- Qualified teachers that are employed by a Scottish local authority looking to undertake a course with a Scottish

Please note that for those applying as qualified teachers, only support for course fees is available.

Other eligibility rules

A thuilleadh air seo, airson a bhith freagairt air an sgeama seo feumaidh tu a bhith a' fuireach ann an Alba, a' gabhail cùrsa le colaiste no oilthigh Albannach, is cead obair ann an Alba mar neach-obrach tràth-bhliadhnaichean no neach-teagaisg Gàidhlig a bhith agad as dèidh dhut an cùrsa a chrìochnachadh.

Ma tha thu a' freagairt air riaghailtean airson [Sgeama Bursaraidhean Teagaisg aig Riaghaltas na h-Alba / Leasachadh Sgilean na h-Alba](#) agus soirbheachail ann a bhith a' cur iarrtas a-steach, cha bhi e ceadaichte dhut taic-airgid fhaighinn tron sgeama Bhòrd na Gàidhlig. Ma tha thu a' clàradh airson cùrsa PGDE, tha sinn a' moladh gu mòr gum bheir thu sùil air riaghailtean na sgeama sin is iarrtas a chur a-steach ma tha sin ceadaichte, leis gur dòcha gum bi thu airidh air bursaraidh de suas ri £20,000.

Uaireannan, thèid beachdachadh air iarrtasan bho oileanaich a tha airson cùrsaichean cànan Gàidhlig a dhèanamh (m.e. cùrsaichean goirid no cùrsaichean air astar) mus tèid iad air adhart gu cùrsa ITE. Bu chòir dhut bruidhinn ri Bòrd na Gàidhlig mus cuir thu iarrtas a-steach airson an t-seòrsa taice seo.

Feumaidh cunntas-banca san RA a bhith agad nuair a tha thu a' cur an iarrtais agad a-steach (mura bheil thu a' sireadh taic le cìsean a' chùrsa a-mhàin).

Thoir fa-near nach urrainn dhut taic-airgid iarraidh tron sgeama seo ma tha thu a' faighinn taic tron ùghdarras ionadail agad tron sgeama Tabhartasan Cùrsaichean Bogaidh againn, is chan fhaod thu ach aon iarrtas a chur a-steach dhan chuairt maoineachaidh seo.

In addition to the above, to be eligible you must be resident in Scotland, be taking a course with a Scottish college or university and have the right to work in Scotland as a Gaelic early years practitioner or teacher after completion of the course.

If you meet the [criteria for the Scottish Government/Skills Development Scotland Teaching Bursary Scheme](#) and are successful in applying, you will be ineligible to receive support through the Bòrd na Gàidhlig scheme. If you are enrolling on a PGDE course, we strongly recommend reviewing the eligibility criteria for this scheme and applying if you are eligible, as you may be eligible for a bursary of up to £20,000.

In some cases, applications will be considered from students wishing to take Gaelic language courses (e.g., short courses or distance learning course) prior to an ITE (Initial Teacher Education) course. Any such application should be discussed with Bòrd na Gàidhlig prior to submission.

It is essential that you have an active UK bank account at the time of applying (unless you are seeking support for course fees only).

Please note you cannot apply for support through this fund if you are already receiving support via your local authority through our Gaelic Immersion Course Grants scheme, and you can only submit one application to this round of funding.

Dè an taic a gheibhear?

What support is available?

Gheibhear taic airson cosgaisean bith-beò, pàigheadh cìsean a' chùrsa, no an dà chuid, a-rèir an cùrsa a tha thu a' dèanamh is taic eile air a bheil thu airidh.

Gheibhear eisimpleirean de thabhartasan a tha rim faighinn tron sgeama san Eàrr-ràdh dhan stiùireadh seo.

Support is available as a cost of living grant, for payment of course fees, or both, depending on the course you are undertaking and your eligibility for other support.

Worked examples of grant sums available are available in the Appendix to these guidelines.

Thoiribh fa-near gum bi na suimeannan tabhartas a rèir a' bhuidseit iomlain ri fhaighinn airson an sgeama, is dh'fhaodadh gun tèid an ìsleachadh bho na h-ìrean air ainmeachadh san stiùireadh seo ma tha àireamh nan iarrtasan nas àirde na bhathar an dùil.

Tabhartasan Bith-beò

Tha tabhartas ri fhaighinn bho Bhòrd na Gàidhlig airson taic a chur ri cosgaisean bith-beò fhad 's a tha thu a' gabhail cùrsa HNC, HND, fo-cheum no iar-cheum a tha ceadaichte airson teagaisg sa Ghàidhlig no airson tràth-bhliadhnaichean is cùraim-cloinne Ghàidhlig (faicibh t.d. 1).

Faodaidh gach oileanach làn-thìde a tha clàraichte air cùrsa freagarrach sùim choitcheann de suas ri **£700** (no £350 airson oileanaich pàirt-thìde) iarraidh.

Please note that all grant sums will be offered subject to the total budget available for the scheme and may be lower than the maximums set out in this guidance in the event of a higher-than-expected volume of applications.

Cost of Living Grants

A grant is available from Bòrd na Gàidhlig for the cost of living while you are undertaking an eligible HNC, HND, undergraduate or postgraduate Gaelic teaching or Gaelic early years and childcare course (see page 1).

All full-time students registered on an eligible course can apply for a core amount of up to **£700** (or £350 for part-time students).

Additional sums beyond the core amount can be requested depending on different factors as outlined below:

*Tha taic a bharrachd air sgàth is gu bheil thu air a bhith ann an obair làn-thìde ri fhaighinn ma tha thu air a bhith ag obair gu leantainneach (ag obair 30 uairean a thìde san t-seachdain no barrachd na sin) no air Cuibhreann Neach- cùraim fhaighinn airson co-dhiù 12 mìosan, is gun a' bheàrn nas fhaide na 2 mhìos eadar dreuchdan, agus an dreuchd mu dheireadh agad air crìochnachadh 6 mìosan ro thoiseach a' chùrsa agad air a' char as fhaide.

Bidh fòrladh màthaireil, athaireil, uchd-mhacachd, tinneas no fòrladh-obrach air sgàth a' choròna-bhìoras sam bith bho dhreuchdan a' cunntadh air a bhith air fhadhadh gu leantainneach airson nan riaghailtean seo.

*Extra support due to previously being in full-time work is available if you have been employed full-time (working 30 hours or more per week) or have received Carer's Allowance continuously for at least 12 months, with no more than a gap of 2 months between any posts, and your latest post ending no later than 6 months before the start of your course.

Any maternity, paternity, adoption, sick leave or coronavirus-related furlough from posts will count as having been employed continuously for the purposes of these rules.

Amount will be calculated on a pro-rated basis, e.g., 1 year and 200 days of employment = £1,548 (full-time course) / £774 (part-time course).

**Tha an tabhartas a bharrachd dhaibhsan a tha air a bhith ann an cùram ri faighinn ma tha ùghdarras ionadail san RA air coimhead às do dhèidh ro aois 18.

Cìsean a' chùrsa

Faodaidh tu taic iarraidh airson cìsean a' chùrsa agad mura bheil thu airidh air taic fhaighinn tro SAAS (Buidheann Tabhartais Oileanach na h-Alba) airson cùrsa HNC/HND, fo-cheum no iar-cheum, no ma tha thu nad thidsear le teisteanas fastadh le ùghdarras ionadail Albannach a tha air leasachadh proifeasanta a dhèanamh le bhith a' gabhail cùrsa.

Ma tha thu a' gabhail cùrsa far a bheil cìsean a' chùrsa air a phàigheadh le bhuidheann eile, leithid Riaghaltas na h-Alba a tha pàigheadh cìsean a' chùrsa airson cùrsa MEd Foghlaim Gàidhlig, chan eil e ceadaichte dhuibh iartras a chur a-steach dhan sgeama seo airson taic le cìsean a' chùrsa.

Ma tha thu a' gabhail cùrsa fo-cheum no iar-cheum, feumaidh tu tagradh airson taic airson cìsean a' chùrsa a chur gu SAAS sa chiad dol a-mach, agus ma thèid seo a dhiùltadh faodaidh tu tagradh a dhèanamh airson taic bhon sgeama seo. Feumaidh tu fianais a chur a-steach còmhla ris an iartras agad.

Ma tha thu a' gabhail cùrsa nach eil airidh air taic SAAS chan fheum thu an dearbhadh seo a thoirt seachad.

**The additional grant for care-experienced people is available if you have been looked after by a local authority in the UK before the age of 18.

A maximum of £5,000 in grants is available per person over the duration of a course (support for course fees are not counted towards this figure).

Course fees

You can apply for support for your course fees if you are not eligible to receive support via SAAS (Student Awards Agency Scotland) for an HNC/HND, undergraduate or postgraduate course, or are a qualified teacher employed by a Scottish local authority looking to undertake professional development by undertaking a course.

If you are studying for a course where course fees are paid for by another organisation, such as the Scottish Government who pay for course fees for the MEd Gaelic Education course, you are not eligible to apply via this scheme for support towards those course fees.

If you are studying for an undergraduate or postgraduate course, you must in the first instance apply for support for course fees from SAAS, and if this is rejected you may apply for support from this scheme. Evidence that you do not qualify for support from SAAS will need to be supplied with your application.

If you are studying a course which is not eligible for SAAS support, you do not need to provide this confirmation.

Submitting an application

You should talk to Bòrd na Gàidhlig as soon as possible if you have any questions about your application by sending an email to foghlam@gaidhlig.scot or tabhartas@gaidhlig.scot

Applications should be submitted via our Fluxx application portal at bng.fluxx.io. An account can be registered for free on the website and it is possible to save the progress of an application whilst working on it. Alternative formats of the application form are available upon request.

You must submit evidence with your application to confirm that you have accepted your place on your current course (if you are entering the first year of a

Evidence of course place acceptance can be provided as a copy of a letter or email from UCAS, the university or college. If your offer of a course place is conditional, you can still apply, but a grant will not be offered until you provide evidence to us that you have fulfilled the conditions and received an unconditional offer of a course place.

Depending on your request, you may also need to submit further evidence of the following:

How we will handle your application

Thèid na h-iarrtasan uile a mheasadh aig tòiseach na Sultaine 2024 as dèidh dhan sgeama dùnadh, gus dearbhadh gu bheil buidseat gu leòr ann airson an àireamh iarrtasan a thathar air fhaighinn, is thèid co-dhùnadh a mhìneachadh dhut tro phost-dealain ro **dheireadh na Sultaine 2024**.

All applications will be assessed together in early September 2024 after the scheme closes, to ensure that there is sufficient budget to support the number of applications received, and a decision will be communicated to you by email by the **end of September 2024**.

Ma tha fad a bharrachd iarrtasan na leigeas le buidseat an sgeama, thèid suimeannan tabhartais aig na h-iarrtasan soirbheachail a lùghdachadh ann an dòigh cho-ionannach, ach cha bhith buaidh air taic do chìsean cùrsaichean.

If there are significantly more applications than the budget of the fund can allow, a proportionate reduction in grant sums across all successful application will take place, although course fee support will be unaffected.

If your funding application is successful, a letter of offer will be sent to you by email via Docusign. This will explain the level of funding agreed and the conditions that apply and ask you to confirm your bank details to allow us to make grant payments you.

If support for course fees is agreed, we will ask you to arrange for your college or university to provide us with an invoice for the payment of the fees directly to them. If you have paid for your course fees in advance of a decision on your application, we may require proof of payment to the college or university in order for us to make the payment to you directly.

If support for a grant is agreed, it is expected that 80% of the grant will be paid upon return of the signed letter of offer and confirmation of your bank details. Please note that if funding has been received in previous years that progress reports for those years must be submitted and approved before we can make any payment under your new grant. Payment of the final 20% of the grant will be at the end of the academic year and will be conditional
