Mu dheidhinn na Maoine

'S e Taic Freumhan Coimhearsnachd a' phrìomh mhaoin aig Bòrd na Gàidhlig airson taic a chur ri buidhnean coimhearsnachd ann a bhith a' libhrigeadh phròiseactan a bhios a' cur air adhart cleachdadh is ionnsachadh na Gàidhlig aig ìre na coimhearsnachd. Am-bliadhna tha sinn a' toirt a-steach sgeama Cholmille còmhla ri Taic Freumhan Coimhearsnachd mar aon mhaoin gus taic a chumail ri Gàidhlig sa choimhearsnachd.

Bidh an sgeama a' toirt cothrom seachad do bhuidhnean cur a-steach airson suas ri 2 bliadhna de thaic-airgid, airson phròiseactan nas fhaide no feadhainn a tha a' ruith gach bliadhna. 'S e £200,000 am buidseat ris a bheil dùil airson an sgeama, ach tha seo ri dhearbhadh a rèir buidseat Bòrd na Gàidhlig 2025/26.

Tha co-fharpais air a bhith ann tro chuaritean eile den sgeama seo, agus mar sin tha sinn an dùil nach gabh taic a chumail ris a h-uile iarrtas freagarrach.

Bidh sùbailteachd san sgeama airson taic a chumail ri iomadh seòrsa pròiseict a tha ag amas air daoine a thoirt còmhla gus Gàidhlig a chleachdadh, ach tha sinn gu sònraichte airson taic a chumail ri:

- Tachartasan Gàidhlig sa choimhearsnachd agaibh is air-loidhne
- Pròiseactan is cothroman a tha a' brosnachadh dhaoine òga a' Ghàidhlig a chleachdadh còmhla
- Pròiseactan a tha brosnachadh cleachdadh na Gàidhlig am measg theaghlaichean is eadar ginealaichean
- Ionnsachadh inbhidh Gàidhlig sa choimhearsnachd
- Colmille – Togail cheanglaichean eadar luchd-labhairt na Gàidhlig is Gaeilge

Anns an iarrtas agaibh, tha sinn airson 's gum mìnich sibh mar a bhios am pròiseact agaibh a' freagairt air aon no barrachd air aon de na h-amasan seo. Bu chòir dhuibh cuideachd a bhith mothachail air mar a bhios am pròiseact agaibh a' cur ri [Plana Corporra Bòrd na Gàidhlig 2023-28](#) agus ri [Plana Nàiseanta na Gàidhlig 2023-28](#).

About the Fund

Taic Freumhan Coimhearsnachd is Bòrd na Gàidhlig's primary fund for supporting community organisations in delivering projects to promote and increase the usage and learning of Gaelic at community level. This year we are bringing the Colmille scheme together with Taic Freumhan Coimhearsnachd into a single fund to support community Gaelic usage.

The fund offers the opportunity to apply for up to 2 years' worth of funding, for longer-term projects or those that are recurring annually. The estimated budget for the scheme is £200,000, pending confirmation of Bòrd na Gàidhlig's 2025/26 budget.

Previous rounds of the fund have been competitive, therefore we expect that not all applications that are suitable will be successful.

The fund is flexible in supporting most types of projects that seek to bring people together to use Gaelic, but we are particularly looking to support:

- Gaelic events in your community and online
- Projects and opportunities that encourage young people to use Gaelic together
- Projects that support Gaelic usage among families and between generations
- Adult Gaelic learning in the community
- Colmille – Building connections between speakers of Gaelic and Irish

In your application we expect you to expand on how your project meets one or more of these aims. You should also be aware of the how your project may contribute to [Bòrd na Gàidhlig's Corporate Plan 2023-28](#) and the [National Gaelic Language Plan 2023-28](#).

Ann a bhith a' measadh an iarrtais agaibh, bidh sinn a' coimhead gu sònraichte air:

- Luach an airgid a tha ga shealltainn leis a' phròiseict Mar a tha am buidheann a' coileanadh dhleastanasan a thaobh na h-Àrainneachd, Co-ionannachd is Obair Chothromach

In assessing your application, we will be primarily looking at:

- How clearly your project shows that it will promote the use of Gaelic in your community and achieve the specific aims we have for this year
- The ability of your organisation to deliver the project successfully
- The strength of your plans to assess the impact of your project
- The value for money demonstrated by the project
- How your organisation fulfils responsibilities in terms of the Environment, Equalities and Fair Work

Project Requirements

Cò dh' fhaodas tagradh a chur a-steach?

Tha a' mhaoin seo fosgailte do bhuidhnean treas-roinn stèidhichte (carthannasan no buidhnean saor-thoileach) a tha stèidhichte ann an Alba aig a bheil bun-reachd agus a tha airson pròiseact a libhrigeadh gus cleachdadh na Gàidhlig a bhrosnachadh am measg coimhearsnachd air ainmeachadh. Gheibhear eisimpleirean de phròiseactan a fhuair taic bho Taic Freumhan Coimhearsnachd a-cheana [tron làrach-lìn GrantNav](#).

Chan fhaod buidhnean ach **an** iarrtas a chur a-steach dhan chuairt seo den mhaoin.

Ma tha sibh air taic fhaighinn tro chuairt 2024-26 den sgeama (air a toirt seachad sa Ghearran/Màrt 2024), chan fhaod sibh iarrtas a dhèanamh ach a-mhàin ma tha am pròiseact maoinichte agaibh a' crìochnachadh ann an 2025 agus am pròiseact ùr tòiseachadh ann an 2025 cuideachd. Ma tha ceistean sam bith agaibh a thaobh freagarrachd, cuiribh fios gu Bòrd na Gàidhlig cho luath 's a ghabhas.

Feumaidh cunntas-banca san RA a bhith aig a' bhuidhinn agaibh cuideachd, fo ainm na buidhne, nuair a tha sibh a' cur an iarrtais a-steach. Ma tha a' bhuidheann agaibh an sàs ann am pròiseas cunntas banca ùr fhosgladh, chan urrainn dhan bhuidhinn agaibh iarrtas a chur a-steach.

Cò nach fhaod tagradh a chur a-steach?

- Daoine fa-leth
- Ùghdarrasan poblach no ionadail (is ALEOs)
- Buidhnean coimeirsealta/airson prothaid
- Buidhnean Com-pàirteach Libhrigidh Bòrd na Gàidhlig

Who can apply?

This fund is open to constituted third-sector (charities or voluntary organisations) based in Scotland that hope to deliver a project to promote the use of Gaelic within a given community. Examples of projects that have previously received support through Taic Freumhan Coimhearsnachd [can be found via the GrantNav website](#).

Organisations may submit a maximum of **one** application in this funding round.

If you received support through the 2024-26 funding round of the scheme (awarded in February/March 2024), you will only be eligible to apply for support if your currently funded project ends in 2025 and your new projects also begins in 2025. If you have any questions about your eligibility please get in touch with Bòrd na Gàidhlig as soon as possible.

It is also essential that your organisation has an active UK bank account, in the name of the organisation, at the time of submitting the application. If your organisation is in the process of applying for the opening of a bank account, your organisation is ineligible to apply.

Who cannot apply?

- Individuals
- Public or local authorities (including ALEOs)
- Commercial or for-profit organisations
- Bòrd na Gàidhlig Delivery Partners

Clàr-ama a' Phròiseict

Bidh an sgeama a' toirt taic do phròiseactan a thèid an tòiseachadh eadar 1 Giblean agus 31 Dùbhlachd 2024 agus a thèid crìochnachadh ro 31 Lùnastal 2026.

Thathar an dùil gun tèid an ath chuairt maoineachaidh a ruith eadar Samhain 2025 is Faoilleach 2026 airson pròiseactan 2026-28.

Dè tha cosgaisean a gheibh taic?

Faodaidh sibh suas ri £5,000 iarraidh ma tha pròiseact a' maireachdainn suas ri 12 mìosan no suas ri £10,000 ma tha pròiseact a' maireachdainn nas fhaide na 12 mìosan.

Faodaidh sibh iarraidh suas ri 80% de chosgaisean iomlan a' phròiseict, fhad 's a tha seo fon t-suim iomlan air ainmeachadh gu h-àrd.

Bu chòir dhuibh dèanamh cinnteach nach eil pàirt sam bith eile de bhuidseat a' phròiseict air am maoineachadh tro sgeamaichean maoineachaidh eile, Maoin nan Ealan Gàidhlig air a ruith le Fèisean nan Gàidheal, Maoin nan Tabhartasan Beaga aig Seachdain na Gàidhlig no [Buidhnean Com-pàirteach Libhrigidh Bhòrd na Gàidhlig](#).

Bu choir pròiseactan amas air teachd-a-steach iomchaidh fhaighinn bho chom-pàirtichean far a bheil seo comasach (m.e. cìsean airson chlasaichean Gàidhlig, airgead bho phàrantan airson turasan sgoile, tiocaidean airson chuirmean), agus is mathaid gun cuir sinn cumha air an taic-airgid againn gum bi sibh a' togail ìre de dh' airgead bho bhunan den leithid ma tha an t-iarrtas agaibh soirbheachail.

Bu chòir gach pròiseact a tha a' pàigheadh tuarastalan no cìsean dhan fheadhainn a tha a' libhrigeadh a' phròiseict a bhith a' pàigheadh co-dhiù [Tuarastal Bith-beò fìor \(a tha £12.60 san uair an-dràsta\)](#). Ma tha sibh a' cleachdadh tuarastal gnìomhachais anns na figearan agaibh, nach cuir sibh fios a-steach dhan iarrtas air cò a shuidhich na h-ìrean agus ceangal ann gus am fiosrachadh a lorg.

Tha cosgaisean neo-ionmhasail/saor-thoileach ceadachte mar phàirt de chosgaisean iomlan a' phròiseict. Faodar taic neo-ionmhasail airson ùine air a thoirt seachad gu saor-thoileach a thuairmse le luach de cho-dhiù am Fìor Thuarastal Bith-beò no tuarastal gnìomhachais iomchaidh, ma tha sin ri fhaighinn, is bu chòir seo a bhith air ainmeachadh sa bhuidseat an dà chuid mar theachd-a-steach agus cosgaisean.

Project Timeframe

The fund will support projects which will start between 1 April and 31 December 2025 and will be fully completed by 31 August 2027.

It is expected that the next funding round will run from November 2025 to January 2026 for 2026-28 projects.

What costs are supported?

You may request up to £5,000 for projects with a duration of up to 12 months, or £10,000 for projects with a duration over 12 months.

You can apply for a maximum of up to 80% of project costs as long as this is below the maximum sum stated above.

You must ensure that no other part of the project's budget is funded by money from other Bòrd na Gàidhlig funding schemes, the Gaelic Arts Fund run by Fèisean nan Gàidheal, Seachdain na Gàidhlig's Small Grants Fund or [Bòrd na Gàidhlig's Delivery Partners](#).

Projects should aim to have income from participants where possible (e.g. fees for Gaelic classes, parental contributions towards school trips, tickets for concerts) and we may set conditions on our funding that a minimum level of income is received through such contributions if your application is successful.

All projects that pay wages or fees to those delivering the project must pay at least the [real Living Wage \(currently £12.60 per hour\)](#). If using industry rates in your budget, please include information about who set the rates and a link to verify this information.

In-kind/volunteer costs are permitted as part of a contribution towards total project costs. Any in-kind support for volunteered time can be calculated with a minimum value of the real Living Wage or an appropriate industry rate, if available, and should be budgeted as both income and expenditure.

- Duaisean co-fharpaisean
- Lìbhrigeadh curraicealam na sgoile
- Seiseanan tràth-bhliadhnaichean

Ciamar a thèid sinn ar phàigheadh?

Ma tha an t-iarrrtas agaibh soirbheachail, ma tha dùil agaibh gum bi am pròiseact crìochnachadh taobh a-staigh 12 mìosan, gheibh sibh 80% den tabhartas iomlan às dèidh dhuibh an t-aonta taic-airgid is aithisgean sam bith a tha a dhìth airson phròiseactan eile a chur a-steach, leis an 20% mu dheireadh air a phàigheadh às dèidh dhuibh aithisg dheireannach iomchaidh a thoirt seachad airson a' phròiseict.

Airson phròiseactan a thathar an dùil a ruith airson còrr is 12 mìosan, gheibh sibh, sa chumantas, 40% den tabhartas iomlan às dèidh dhuibh an t-aonta taic-airgid is aithisgean sam bith a tha a dhìth airson phròiseactan eile a chur a-steach. Bidh suas ri 50% den tabhartas ri phàigheadh às dèidh dhuibh aithisg adhartais a chur a-steach letheach slighe tron chlàr-ama a bha an dùil airson a' phròiseict, is an 10% mu dheireadh (ma tha e a dhìth) ri phàigheadh às dèidh dhuibh aithisg dheireannaich iomchaidh a thoirt seachad.

Bitheamh mothachail gu bheil gach pròiseact air am maoinachadh air stèidh rèidh, agus gum bi dleastanas oirbh taic-airgid Bòrd na Gàidhlig sam bith nach deach a chleachdadh air pròiseact tilleadh thugainn.

Ag aithneachadh taic

Mar bhuidheann phoblach, tha e cudromach dhuinn gu bheil fios aig a' phoball air mar a tha sinn a' cleachdadh ar cuid airgid, is mar sin tha e cudromach gu bheil sibh ag aithneachadh gun tug Bòrd na Gàidhlig taic-airgid dhan phròiseact agaibh (far a bheil sin iomchaidh). Ma tha an t-iarrrtas agaibh soirbheachail, bidh dleastanas oirbh an taic-airgid againn aithneachadh ann an diofar dhòighean tron phròiseact is fios a thoirt seachad dhuinn sna h-aithisgean agaibh air mar a rinn sibh seo.

We will not support project costs relating to:

- Organisation start-up or ongoing running costs
- Costs relating to running, attending or taking part in the Royal National Mòd or local Mòds
- Local Fèisean (which are funded by Bòrd na Gàidhlig through Fèisean nan Gàidheal)
- Air travel (please consider lower-emission options)
- Equipment costs of over £500 in total
- Competition prizes
- Delivery of the school curriculum
- Early years sessions

How will we be paid?

If your application is successful, if your project is expected to complete within 12 months, you will typically receive 80% of the total grant after returning the signed funding agreement and any outstanding reports for other projects, with the final 20% payable after you have submitted a satisfactory end of project report.

For projects expected to run for over 12 months, you will typically receive 40% of the total grant after returning the signed funding agreement and any outstanding reports for other projects. Up to 50% of the grant will be payable after completing a progress report around half-way through your project's expected duration, with the final 10% payable (if required) after you have submitted a satisfactory end of project report.

Please note that projects are funded on a break-even basis, so that you will be required to return to us any Bòrd na Gàidhlig funding that is not utilised in completion of the project.

Acknowledgment

As a public body it's important to us that the public know where our funding is spent, and that's why it's important that you acknowledge where appropriate that Bòrd na Gàidhlig provided funding for your project. If your application is successful, you will be required to acknowledge our grant in various ways throughout the project and to provide information to us in your reporting as to how you have carried this out.

Sgrùdadh is measadh air a' phròiseact

Ma tha an t-iarrtas agaibh soirbheachail, bidh agaibh ri sgrùdadh is measadh a dhèanamh air mar a thèid am pròiseact agaibh a libhrigeadh agus a' bhuidhe aige a shealltainn sna h-aithisgean a thèid iarraidh oirbh.

Feumar aithisg dheireannach a chur a-steach airson gach pròiseact a thèid a mhaoineachadh, agus ma tha dùil gum bi am pròiseact agaibh a' maireachdainn nas fhaide na 12 mìosan, feumaidh sibh aithisg adhartais a chur a-steach mu letheach slighe tro fhaid a' phròiseict agaibh.

Aig a' char as lugha, bidh sinn ag iarraidh oirbh clàradh cia mheud duine a tha a' gabhail pàirt sa phròiseact agus faighneachd de chom-pàirtichean (no sampall de na chom-pàirtichean airson tachartasan/pròiseactan mòra) airson fios fhaighinn air beachdan aca air buaidh am pròiseact air an cleachdadh, ionnsachadh no beachd aca den Ghàidhlig.

Thèid iarraidh oirbh san fhoirm-iarrtais mar a bhios sibh an dùil sgrùdadh a dhèanamh air a' phròiseas, dè na thargaidean a bhios sibh a' cleachdadh gus measadh an robh am pròiseact soirbheachail is mar a bhios sibh a' trusadh fiosrachaidh bho chom-pàirtichean.

Project monitoring and evaluation

If your application is successful you will need to monitor and evaluate your project delivery and show the impact of the project in reports requested from you.

All funded projects will be required to submit a final report and if your project is expected to last for over 12 months, you will be required to complete a progress report approximately halfway through your project's duration.

At a minimum we will ask all projects to note how many people take part in the project and to ask participants (or a sample of participants for large events/projects) for feedback on the impact of the project on their usage, learning or opinion of Gaelic.

In the application form we'll ask you how you intend to monitor the project, what targets you will use to assess whether the project is successful, and how you will gather feedback from participants.

Reports will be available to submit via the [Fluxx application portal at https://bng.fluxx.io](#), and will be viewable if your application is approved.

Fair Work

Organisations in receipt of public funding in Scotland are required to adhere to the Scottish Government's Fair Work First policy, and as such **must**:

- Pay at least the real Living Wage; and
- Provide appropriate channels for effective workers' voice, such as trade union recognition

You will be asked as part of your application and reporting to confirm that you are adhering to the policy and provide evidence of doing so.

You will receive an automatic email acknowledgment from the Fluxx portal to confirm that we have received your application. If you do not receive this, please check that you have submitted the application rather than only saving the application.

Bòrd na Gàidhlig officers will then screen applications after submission to ensure they comply with the rules of the fund and have provided required information. If your application is deemed ineligible, you will be asked to correct this. If your application is not fully compliant with the rules of the fund by **10am on Monday 10 February 2025** your application may be declined without assessment.

All eligible applications will be assessed by a panel of Bòrd na Gàidhlig officers according to [the assessment guidance](#), and they will make recommendations to the Bòrd na Gàidhlig Senior Management Team who will decide on the outcome of applications.

If you have been awarded funding, a letter of offer will be sent via Docusign to your nominated signatory (or signatories if you are an organisation with staff and required to complete a Fair Work Declaration). You will have up to 30 days from the date of issue to accept the offer (including terms and conditions) or the offer shall lapse.

If you are not satisfied with the outcome of your application, while we do not offer an appeal process you may make a complaint if you believe your application has not been dealt with in accordance with this guidance and the assessment guidance.
